DECLARATION OF CANDICE MCHUGH IN SUPPORT OF MCCAIN FOODS USA, INC.'S RESPONSE IN GROUND WATER DISTRICTS' MOTION TO STAY, MOTION FOR INJUNCTIVE RELIEF, MOTION TO COMPEL, MOTION FOR EXPEDITED DECISION AND APPLICATION FOR ORDER TO SHOW CAUSE

- I, Candice McHugh hereby declare and state as follows:
- 1. I am over the age of 18 and state the following based upon my own personal knowledge.
- 2. I am one of two owners of McHugh Bromley, PLLC, the law firm that represents McCain Foods USA, Inc. in this matter.
- 3. Our firm's other clients, the Cities of Bliss, Burley, Carey, Declo, Dietrich, Gooding, Hazelton, Heyburn, Jerome, Paul, Richfield, Rupert, Shoshone, and Wendell (the "Coalition of Ciites") are parties to the underlying administrative action and thus, as their attorney, I received notice of the Director's *Fifth Amended Final Order Regarding Methodology for Determining Material Injury to Reasonable In-Season Demand and Reasonable Carryover* ("*Fifth Methodology Order*"); and *Final Order Regarding April 2023 Forecast Supply (Methodology Steps 1-3)* ("*As-Applied Order*"). The As-Applied Order states:

On or before May 5, 2023, ground water users holding consumptive water rights bearing priority dates junior to December 30, 1953, within the Eastern Snake Plain Aquifer area of common ground water supply shall establish, to the satisfaction of the Director, that they can mitigate for their proportionate share of the predicted DS of 75,200 acre-feet in accordance with an approved mitigation plan. If a junior ground water user cannot establish, to the satisfaction of the Director, that they can mitigate for their proportionate share of the predicted DS of 75,200 acre-feet in accordance with an approved mitigation plan, the Director will issue an order curtailing the junior-priority ground water user.

- 4. Attached hereto as Exhibit A is a true and correct copy of a letter dated May 1, 2023 to McCain at its address in Burley, Idaho. The letter was received by McCain in Burley, Idaho on May 12, 2023. Exhibit A does not advise McCain of the May 5, 2023 deadline above. Exhibit A does not specify water right numbers that are subject to curtailment.
  - 5. McCain has no water rights senior to December 30, 1953 for use at its Burley facility.
  - 6. Exhibit A states:

Holders of ground water rights potentially subject to curtailment may also

submit a proposed mitigation plan to the Director in accordance with Conjunctive Management Rule 43.1 See IDAPA 37.03.11.043. However, please be aware the approval process for a mitigation plan is time-consuming **A proposed mitigation plan submitted now may not be approved in time for the 2023 irrigation season**. Upon receipt of a proposed mitigation plan, the Director will publish notice for two successive weeks, after which ten days will be allowed for the filing of protests. The Director may hold a hearing if necessary to determine whether a proposed mitigation plan will mitigate injury to the SWC caused by diversions of ground water authorized by junior priority ground water rights. If the proposed mitigation plan is protested, the Director will hold a hearing. **Please be advised that a curtailment order is not stayed pending evaluation of a mitigation plan**.

(emphasis added)

- 7. McCain was not a party to the underlying administrative action and thus, did not receive any notice of the May 5, 2023 deadline. It was only because I had other clients that I was made aware of this deadline and its impact to McCain. On behalf of McCain I filed a Request for Hearing and Objection to Fifth Amended Order and the As-Applied Order a true and correct copy is attached hereto as Exhibit B. McCain also filed a Statement of Issues, a true and correct copy of which is attached as Exhibit H.
- 8. On or about early December of 2022 I was made aware by the Coalition of Cities' expert Greg Sullivan that IDWR was looking at changing its use of the model from a steady-state to transient run which could end up with curtailment dates in the early 1960s late 1950s, which is decades earlier than IDWR has previously predicted with this type of predicted shortfall when using steady-state. Because I also represent McCain, I advised McCain of this development.
- 9. In early January I contacted Travis Thompson, via telephone, about McCain's interest in developing a stipulated mitigation plan with the Surface Water Coalition. He requested data on McCain's water use.
- 10. In late January 2023 or early February 2023, I learned that IDWR staff was not recommending that the model be used in a transient mode to determine priority dates and saw the

December 23, 2023 memo that said as much. A true and correct copy of that memo is attached as Exhibit C hereto.

- 11. However, because McCain had already started to analyze its water use and had engaged technical experts to evaluate possible mitigation options, and because we had already contacted Mr. Thompson, I advised that it would be prudent to continue to evaluate McCain's water use and to develop a stipulated mitigation plan with the Surface Water Coalition if possible as this would protect McCain's water use if the Department ever switched to using the transient method of determining the curtailment date.
- 12. On or about April 6, 2023, I received a preliminary report regarding McCain's water use and possible mitigation options. I was in the process of evaluating this information and had again reached out to Mr. Thompson on or about April 19, 2023.
- 13. On April 21, 2023, when the 2023 Orders were issued and I was made aware of the deadlines and specifically that IDWR was not going to allow for private mitigation plans to be processed without curtailment as stated in Exhibits A, F, and G attached hereto it became clear that McCain had no option but to petition to join Southwest Irrigation District in order to protect its water use. It was simply not possible to meet the May 5, 2023 deadline in the As-Applied Order, nor finalize, file and get approval of its own mitigation plan before the Director stated he would curtail water users in the As-Applied Order. Ex. A; see too Exs. F & G.
- 14. Thus, on behalf of McCain I petitioned Southwest Irrigation District to join its mitigation plan. A true and correct copy of that petition is attached hereto as Exhibit D.
- 15. I filed a Notice of Mitigation on McCain's behalf before the May 5, 2023 deadline. Exhibit E.

16. A true and correct copy of the relevant portions of the transcript containing Director Spackman's comments regarding mitigation plans is attached hereto as Exhibit F and contains highlights of the pertinent discussion.

17. A true and correct copy of the FAQs is attached hereto as Exhibit G.

18. A true and correct copy of the May 26, 2023 email from Garrick Baxter to Candice McHugh is attached hereto as Exhibit I.

I declare under penalty of perjury under the laws of the State of Idaho that the foregoing is true and correct.

RE: Notice of Possible Curtailment of Ground Water Rights with Priority Dates Junior to December 30, 1953 - Surface Water Coalition Delivery Call

Dear Water Right Holder,

You are receiving this letter because, according to the records of the Idaho Department of Water Resources ("Department"), you are the holder of one or more water rights authorizing diversion of ground water from the Eastern Snake Plain Aquifer Area of Common Ground Water Supply ("ESPA") that are not covered by an approved and effectively operating mitigation plan. Because your water right(s) are not currently covered by an approved and effectively operating mitigation plan, your water right(s) may be subject to curtailment this 2023 irrigation season.

On April 21, 2023, the Director of the Department issued the *Final Order Regarding April 2023* Forecast Supply (Methodology Steps 1-3) ("As-Applied Order"). The As-Applied Order predicts a shortfall in the water supply for senior priority Snake River water rights during the 2023 irrigation season, which will result in mitigation requirements or curtailment for ground water rights with priority dates junior to (later than) **December 30, 1953**.

The Department scheduled a hearing for the parties to the As-Applied Order on June 6–10, 2023. After the hearing the Director will decide whether to issue a curtailment order. If the Director issues a curtailment order, ground water rights junior to December 30, 1953, could be subject to curtailment unless the holders of junior priority ground water rights mitigate for ground water diverted pursuant to an approved mitigation plan.

Holders of ground water rights affected by a curtailment order may participate in an approved mitigation plan. See Idaho Code § 42-5259. If you are already a member of a ground water district, please contact and work with the district to ensure the district's records are up to date. If you are not a member of a ground water district, you may want to contact the nearest ground water district to inquire if the district will allow you to join.

Holders of ground water rights potentially subject to curtailment may also submit a proposed mitigation plan to the Director in accordance with Conjunctive Management Rule 43. See IDAPA 37.03.11.043. However, please be aware the approval process for a mitigation plan is time-consuming. A proposed mitigation plan submitted now may not be approved in time for the 2023 irrigation season. Upon receipt of a proposed mitigation plan, the Director will publish notice for two successive weeks, after which ten days will be allowed for the filing of protests. The Director may hold a hearing if necessary to determine whether a proposed mitigation plan will mitigate injury to the SWC caused by diversions of ground water authorized by junior priority ground water rights. If the proposed mitigation plan is protested, the Director will hold a hearing. Please be advised that a curtailment order is not stayed pending evaluation of a mitigation plan.



McCain objects to the *Fifth Amended Order* and the 2023 As-Applied Order's implementation this upcoming season for the reasons set forth below

which it also identifies as issues for hearing. McCain reserves the right to revise the issues as

more information becomes available.

Among the issues the McCain has identified for hearing are:

a) IDWR's new reliance on transient modeling;

Summary of Recommended Technical Revisions to the 4<sup>th</sup> Amended Final Order Regarding Methodology for Determining Material Injury to Reasonable In-Season Demand and Reasonable Carryover for the Surface Water Coalition

12/23/2022

In a status conference on August 5, 2022, the Director of the Idaho Department of Water Resources (IDWR) issued a directive to IDWR staff to convene a committee of experts to review and provide comments on potential technical changes to the "Fourth Amended Final Order Regarding Methodology for Determining Material Injury to Reasonable In-Season Demand and Reasonable Carryover" (Methodology) issued on April 19, 2016. IDWR staff created a technical working group composed of IDWR staff, experts representing the parties to the ongoing Surface Water Coalition (SWC) delivery call, and other interested parties. IDWR identified potential technical changes to the Methodology and presented them to the technical working group for discussion.

IDWR hosted six technical working group meetings between November 16 and December 14, 2022. Before each meeting, IDWR staff circulated PowerPoint presentations and agendas to the working group. The meetings were attended by interested members of the public and consultants and attorneys for parties to the SWC delivery call. Department staff and attorneys also participated. The meetings included presentations by IDWR staff and working group members, as well as open discussion on the topics presented. During the final meeting on December 14, 2022, IDWR staff stated that IDWR would provide a document summarizing staff's preliminary recommendations on potential technical changes to the Methodology.

Based on the information presented at the meetings and distributed to the technical working group, IDWR staff have the following preliminary technical recommendations:

- Update the Baseline Year (BLY) irrigation demand used to determine reasonable in-season demand from the current average of diversion demands for the 2006, 2008, and 2012 irrigation seasons to the diversion demand for the 2018 irrigation season.
- Update the BLY irrigation demand used to determine reasonable carryover for each SWC member from the current average of the diversion demands for the 2006, 2008, and 2012 irrigation seasons to the diversion demand for the 2018 irrigation season.
- Update the project efficiency value used to calculate monthly reasonable in-season demand from a rolling average of the previous eight years to a rolling average of the previous fifteen years.

At this time, staff do not have recommendations on utilizing near real time METRIC for determining crop water need, updating April and July regressions to improve their predictive power for natural flow supply, or using transient model simulation for determining curtailment priority dates. IDWR will continue to evaluate the integration of these and other techniques into the methodology.

IDWR requests written comments from the technical working group on the above recommendations or any other topic covered during the meetings. Please submit any comments no later than January 16, 2023, to matthew.anders@idwr.idaho.gov.

I am writing on behalf of McCain Foods USA, Inc. (the "Company") asking that the Company be allowed to join Southwest Irrigation District for mitigation as soon as possible. The water rights owned by the company and for which it is asking to be covered are listed below in Table 1.

As of the date of this letter, I understand via conversations with Mr. Higgs, that the rate for non-irrigation rights is \$900.00 per cfs. He provided me with a spreadsheet of what he understood the costs would be to the Company. This spreadsheet is attached as Exhibit A. The Company is ready to remit payment as required by the Board in order to be covered by Southwest Irrigation District mitigation plan this year and as an ongoing member of the Irrigation District. Mr. Higgs indicated that the Board may consider asking the Company for back assessments. If the Board elects to charge back assessments, please let the Company know what those charges will be so that these additional charges can be considered and proper payment remitted. As you know, and as reflected in Exhibit A, the Company has not been using its most junior water rights for several years but under the Director's April 21, 2023, *Final Order Regarding April 2023 Forecast Supply* ("2023 As-Applied Order") its most senior water rights are now subject to curtailment. # Surface Water Coalition Delivery Call, Amended 5<sup>th</sup> Methodology and April 2023 As-Applied Orders

#### **FAQs**

Why did IDWR change the Methodology?

IDWR is obligated to update the Methodology to incorporate new climate and hydrologic data and to ensure adequate protection for senior water users from injury. The new Methodology revises important elements used to determine in-season injury to water supplies and end-of-season injury to storage reservoir carryover. It also revises the method used to calculate curtailment dates, relying on what is referred to as "transient" model analysis, in a manner that may result in earlier curtailment dates than previously predicted.

What changes did IDWR make to the Methodology?

IDWR made the following changes to its Methodology: (1) updated climate, hydrologic, and demand data used by the Methodology to determine injury, (2) updated "base line year," (3) updated "reasonable carryover" volumes for the Surface Water Coalition (SWC), and (4) changed how the Eastern Snake Plain Aquifer Model (ESPAM 2.2) is deployed to calculate a priority curtailment date from "steady state" to transient analysis.

Why did IDWR change the methodology to a transient model?

The Director has concluded that using the ESPA model in steady-state mode is no longer legally supportable because steady state does not provide water at the time, place, and quantity needed by the senior water user.

Does this mean that 940,000 acres will be curtailed along the East Snake Plain Aquifer?

No, many irrigated acres are covered by approved mitigation plans and are not subject to curtailment.

 How many acres will be curtailed that IDWR estimates are NOT part of an approved mitigation plan?

IDWR will not have an estimate for this number until it works through curtailment with individual water right holders.

How can there be curtailment in a year when we have so much snow in the hills?

The As-Applied order is an early season prediction of what the water supply for the SWC will be for the upcoming year. The courts have been clear that the Director's predictions must favor the senior water users. And while there is a good snowpack in the hills above the ESPA, that is only part of the water supply for the SWC. Additional supply comes from recharge from the aquifer and that is at a record low. Plus, we are coming out of two years of drought and the existing storage supply was low.

 Are water users immediately subject to curtailment with the issuance of the Methodology and As-Applied orders? No. The Director has scheduled a contested case hearing (June 6-10, 2023) to allow parties to submit testimony and evidence regarding the changes to the Methodology implemented by the Director. Because of the pending hearing, the Director will delay issuing a curtailment notice to Snake River junior water users until after the hearing. This means junior ground water pumpers who do not have approved mitigation plans in place will have a reprieve from curtailment until late June. Junior water users should wait for specific notice and direction from IDWR as to how their individual water rights are affected by this decision. However, water right holders who are junior to 1953 should work with IDWR to understand how their water right could be impacted in the case they are not in compliance and a party to an approved mitigation plan.

The following questions all assume that the Director issues a curtailment order and the water rights at issue are junior to the curtailment date in the order:

- What happens if I am participating in an approved mitigation plan?
  - If you are participating in an approved mitigation plan and the mitigation plan is being complied with, you will not be subject to curtailment.
- What happens if I am participating in an approved mitigation plan but the plan is not being complied with?
  - You will be subject to curtailment.
- What happens if I am NOT part of an approved mitigation plan?
  - You will be subject to curtailment. However, you do have the option to join an approved mitigation plan. This is based on the parties in the approved mitigation plan agreeing to add additional members.
- What happens if I am a party to, and meet the criteria of IGWA's 2009 Storage Water Delivery Mitigation Plan?
  - If IGWA delivers storage water to the SWC in a volume equal to the injury determination, participating members are not subject to curtailment. However, this mitigation plan does not provide safe harbor for future injury determination and IGWA must always secure storage water commensurate with the injury determination regardless of the size of injury (e.g., in July of 2021, the injury determination was ~170 KAF). For example, at the mid-season adjustment, if IDWR determines the injury is greater than its April determination, IGWA will have to secure additional storage water or be subject to curtailment during the season after crops are planted.
- What if I am a party to, and meet the criteria of the SWC-IGWA 2015 settlement agreement?
  - The 2015 settlement agreement was approved as a mitigation plan by IDWR. So long as the ground water districts comply with the mitigation plan, members of the ground water districts are not subject to curtailment.
- What if I am a city participating in a mitigation plan?
  - If you are a city participating in an approved mitigation plan and the mitigation plan is being complied with, you are not subject to curtailment.

What if I am a city NOT participating in a mitigation plan?

You will be subject to curtailment. However, you do have the option to join an approved mitigation plan. This is based on the parties in the approved mitigation plan to agree to add additional members.

• What if I am a processor participating in an approved mitigation plan?

If you are a processor participating in an approved mitigation plan and the mitigation plan is being complied with, you are not subject to curtailment.

• What if I am a processor NOT participating in an approved mitigation plan?

You are subject to curtailment. However, you do have the option to join an approved mitigation plan. This is based on the parties in the approved mitigation plan to agree to add additional members.

• Can I submit a mitigation plan now and get it approved in time for this coming irrigation season?

It is unlikely that a mitigation plan can be approved before a potential curtailment order is issued. Once a plan is submitted, the plan must be advertised and is then subject to a protest deadline. The plan is subject to hearing if protested or if the Director determines a hearing is necessary. This process can take many months.

f) IDWR's use of 2018 as the new baseline year; and

g) IDWR's violation of McCain's due process rights by not providing it actual notice of

the order and requisite deadlines, and even if it was deemed that it was given "notice" because it

shared an attorney with the Coalition of Cities, by giving it less than 10 business days to provide

a mitigation solution after a wholesale change in methodology, by depriving it of the ability to

develop its own mitigation plan to protect its water rights, by requiring compliance with a

IDWR also confirmed with Bill there are three other rights in the name of McCain foods that were NOT brought into SWID for mitigation.

- 45-2749, 8/13/1965, Industrial, 2.85 cfs, 734.7 acre feet
- 45-7137, 5/24/1973, Industrial, 3.43 cfs, 884.5 acre feet
- 45-7241, 5/27/1975, commercial & fire protection, 0.25 cfs, 72 acre feet

IDWR has updated its records to show that the four mitigated rights are covered by SWID. So long as SWID is in compliance with its approved mitigation plan, the four rights should be protected from curtailment.
