QUANTITY:

1,000 CES 19.40 AFY

The quantity under this water right is limited to up to 19.400 acre feet per year, with a diversion rate never to exceed the lesser of 1.00 CFS or twenty-five (25) percent of the rate of flow then available at each point of diversion and, cumulatively, no more than twenty-five (25) percent at the furthest downstream point of diversion in use under water right nos. 92-11067A thru 92-11075 and 92-11080A thru 92-11081D.

Right nos. 92-11067A, 92-11067B, 92-11067C, 92-11067D, 92-11067E, 92-11067F, 92-11067G, 92-11067H, 92-11067J, 92-11067J, 92-11067L, 92-11067M, 92-11067N, 92-11067O and 92-11067P are limited to a total combined annual diversion volume of 19.40 acre feet.

PURPOSE AND PERIOD OF USE:

PURPOSE OF USE ADMINISTRATIVE PERIOD OF USE QUANTITY 01/01 - 12/311.000 CFS 19.40 AFY

Administrative use is for National Forest Administration.

The purpose of use includes, road construction, dust abatement, prescribed fire, vegetation establishment, maintaining riding and pack stock used for administrative purposes, and any other similar incidental administrative uses necessary to fulfill the purposes of the Organic Administration Act of 1897.

PLACE OF USE:

National Forest System Land in the West Fork St Maries River subwatershed (HUC12 170103040703), Emerald Creek subwatershed (HUC12 170103040801), Olson Creek-St Maries River subwatershed (HUC12 170103040802), Merry Creek-Middle Fork St Maries River subwatershed (HUC12 170103040702), Middle Fork St Maries River subwatershed (HUC12 170103040701), West Fork Potlatch River-Potlatch River subwatershed (HUC12 170603060802) and East Fork Potlatch River subwatershed (HUC12 170603060801).


## OTHER PROVISIONS NECESSARY FOR DEFINITON OR ADMINISTRATION OF THIS WATER RIGHT:

This right is limited to the intermittent diversion and use of water for the stated purposes. This water right shall not be used as a basis to prevent the future appropriation of water or the basis to request or initiate a delivery call or otherwise have the Idaho Department of Water Resources, a Water District or a Court curtail or limit distribution in whole or in part, to existing legal uses of water to satisfy this water right. This provision shall not be construed as a basis to curtail the United States' use of water under this right to satisfy junior water rights.

This partial decree is subject to such general provisions necessary for the definition of the rights or for the efficient administration of the water rights as may be ultimately determined by the Court at a point in time no later than entry of a final unified decree. Idaho Code \$ 42-1412(6).

With respect to the issues determined by the above partial judgment it is hereby CERTIFIED, in accordance with Rule 54(b), I.R.C.P., that the court has determined that there is no just reason for delay of the entry of a final judgment and that the court has and does hereby direct that the above partial judgment is a final judgment upon which execution may issue and an appeal may be taken as provided by the Idaho Appellate Rules.




