## PROCEDURAL BACKGROUND

On January 8, 2025, the Special Master entered his Recommendation in the above-captioned matter. Thereafter, the United States Department of Interior, Bureau of Land Management filed a Motion to Alter or Amend the Recommendation. On April 24, 2025, the Special Master entered an Order Amending Special Master's Report. Pursuant to SRBA Administrative Order 1 ("AO1") § 13.c, any party seeking to challenge a decision addressing a Motion to Alter or Amend must file a Notice of Challenge within 14 days following the date the decision was filed. On May 8, 2025, a Notice of Challenge was filed by the United States. No other challenges were filed and the time period for filing a challenge has now expired.

# LODGING OF TRANSCRIPTS

Pursuant to AO1 § 13.d, if requested, transcripts are to be lodged within 35 days following the deadline for filing a Notice of Challenge. No transcripts are requested.

## 1. How to join the meeting by telephone

Dial the telephone number listed above.

- When prompted, enter the meeting ID provided above, followed by #.
- When prompted for a participant code (you will not have one), just enter #
- When prompted, enter the meeting password provided above, followed by #.

- To unmute yourself, click the Unmute button, located in the lower-left corner of the window.
- If joining only by telephone, press \*6 to toggle between unmute/mute.
