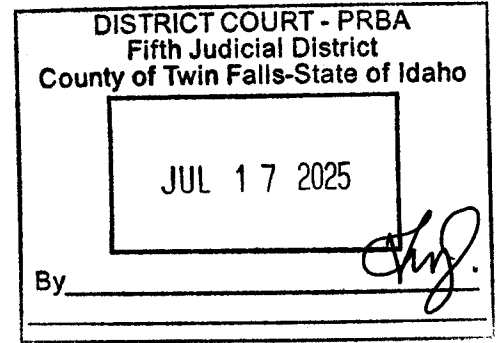

Department of Justice attorneys to conduct litigation on behalf of the United States in any suit before any state court.

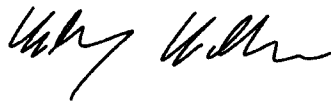
4. Undersigned counsel asserts that she is an attorney actively licensed to practice law in a state of the United States.

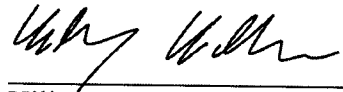
