1. How to join the meeting by telephone

- Dial the telephone number listed above.
- When prompted, enter the meeting ID provided above, followed by #.
- When prompted for a participant code (you will not have one), just enter #
- When prompted, enter the meeting password provided above, followed by #.

2. How to join the meeting online

- To unmute yourself, click the Unmute button, located in the lower-left corner of the window.
- If joining only by telephone, press *6 to toggle between unmute/mute.
