## Trojans travel to start district

Coach hopeful girls' string of injuries, illness is over

Homedale High School starts the 4A District III girls' basketball tournament on the road.

The Trojans fell to host Fruitland, 70-39, in a 4A Snake River Valley conference game Friday.

Senior post Tiana Sorenson scored 15 points for Homedale (4-16 overall, 2-8 in conference), which finished the regular season as the No. 5 seed heading into the district tournament.

"Our outlook for districts is hopeful," HHS coach Benji Sorenson said. "We have been battling a lot of nagging injuries and sickness in the program the last couple weeks, so we hope this is the week we can all get healthy."

Homedale travels to Meridian to play fourth-seeded Cole Valley Christian to open the district tournament Thursday.

"The Cole Valley matchup is always tough, but we like where we are at," Sorenson said. "We played them tough at home early in the year (a 47-34 loss on Dec. 9), but played one of our worst games of the year at Cole Valley earlier this month (a 58-29 setback on Jan. 16).

"I think we matchup well with them. It will just be up to our level of commitment to compete, especially when it comes to rebounding and on the defensive side of the ball."

A win sends the Trojans into Saturday rematch against Fruitland in Payette County in the semifinals.

The Grizzlies blew open last week's conference game against Homedale with a 27-point burst in the second quarter. They put the game away with a 22-8 run after halftime.

Trojans freshman Alivia Campos logged seven points, while Sorenson led the team with eight rebounds.

Sophomore Aaliyah Yost added five points and three rebounds. Senior Belen Asumendi and freshman guard Gracie Jakovac scored four points apiece.

**Jan. 27: McCall-Donnelly 56, Homedale 31** — Sorenson dropped a pair of three-point goals while leading the Trojans with 16 points.

Belen Asumendi scored five points, and Mila Binford and Yost put in four points each.

Stephanie Quezada grabbed four rebounds as the Trojans' seniors worked hard on the glass.

Sorenson snagged six boards, and Asumendi collected five.

## Rebounding rules in Huskies' win

A big start to the second half sent Marsing High School to victory its girls' basketball regular-season finale.

But the 35-23 win on Melba's court on Jan. 26 won't be the last time the Huskies meet their 3A Western Idaho Conference rivals this season.

The two teams open the 3A District III Tournament on Thursday on the Huskies' home floor.

In the precursor to the start of the double-elimination postseason, No. 4 district seed Marsing (13-5 overall, 5-5 in 3A WIC) blew open a close game with a 12-5 third-quarter run.

The fifth-seeded Mustangs (5-15, 2-8) trailed by only a bucket, 17-15, at the break.

Senior Adyson Chadez delivered 21 points, including

hitting three three-point goals, for Marsing.

Another upperclassman, Bailey Daugherty, was the only Huskies player to visit the free-throw line. She missed the shot, but wound up with eight points.

Senior Josie Showalter (four points) and sophomore Abigail Heredia (two) were the only other Huskies to get in the scoring column.

Daugherty snagged seven of her 10 rebounds on offense, while Chadez finished with nine boards and led the team with four steals.

Sophomore Naomi Lewis also ruled on the Huskies' glass with five of her seven rebounds. Showalter six boards were split evenly on both ends of the court.


