**STIPULATED MOTION AND
MEMORANDUM IN SUPPORT
FOR LEAVE TO FILE**

For the reasons set forth below, the Tribe seeks leave to file the executed Settlement Agreement and stipulated water rights notwithstanding the timeline set forth in the Stipulated Process for Effectuating a Settlement Agreement. The Tribe has conferred with counsel for all parties and all are in agreement with this Motion and memorandum in support.


On December 30, 2025, this Court approved the Stipulated Process for Effecting a Settlement Agreement, the Coeur d'Alene Tribe ("Tribe"). Pursuant to that process, once all the non-federal parties executed the Settlement Agreement the Tribe planned to file a fully executed copy of the Settlement Agreement with Exhibits and all individual Stipulated Water Rights with

five (5) days. The Settlement Agreement was fully executed as of February 26, 2026.

Given the amount of stipulated water rights that all Parties has to sign in addition to the Settlement Agreement, and the process for finalizing and printing all documents, the Tribe underestimated the amount of time it would take to prepare the filing. As such, the Tribe seeks leave to file the executed Settlement Agreement with Exhibits, and all individual Stipulated Water Rights and draft Partial Decrees.

The Tribe is filing this Motion via fax. The Tribe is also mailing via overnight UPS mail for delivery on March 31, 2026, the executed Settlement Agreement with Exhibits, and all individual Stipulated Water Rights and draft Partial Decrees. A notice of filing outlining the mailed filing will be placed in the boxes with the filings.
