On March 30, 2026, the Coeur d'Alene Tribe filed a Stipulated Motion for Leave to File. Under the Stipulated Process for Effectuating a Settlement Agreement previously filed in this case, the Tribe planned to file with the Court a fully executed copy of the Settlement Agreement with Exhibits and all individual Stipulated Water Rights within five days of the signing of the fully executed Settlement Agreement by the non-federal parties. The Settlement Agreement was fully executed as of February 26, 2026. The Stipulation Motion asks for an extension of time until March 31, 2026, to file with the Court a fully executed copy of the Settlement Agreement with Exhibits and all individual Stipulated Water Rights. Counsel for the Tribe states she has conferred with counsel for all other parties, and none oppose the Motion. Therefore, the Court will grant the Stipulation Motion on the basis it is unopposed.


THEREFORE, BASED ON THE FOREGOING, THE FOLLOWING ARE HEREBY ORDERED:
