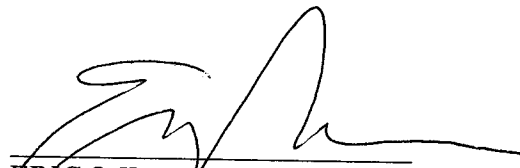

) ORDER OF REFERENCE APPOINTING
) THEODORE BOOTH AS SPECIAL
) MASTER FOR CASA DEL NORTE'S
) BASIN 37 CLAIMS

On May 4, 2026, the United States of America acting through the Department of Interior, Bureau of Land Management, Idaho State Office filed an objection in subcase 61-12361 stating that the use of water under the following rights is limited to a total combined use of 0.02 cfs and 13,000 gpd: 37-23270, 37-23273, 37-23274, 37-23275, 37-23276, 37-23283, 61-12361, 61-12362, 61-12363, 61-12368, 61-12369, 61-12370, 61-12371, 61-12375, 61-12376, 61-12380, 61-12382, 61-12383, 61-12387, 61-12388, 61-12389, 61-12396, 61-12398, 61-12400, 61-12401, 61-12403, 61-12405, 61-12407, 61-12440, 61-12489, 61-12490, 61-12491, 61-12492, 61-12536. Due to Basin 37 being originally appointed to Special Master Bilyeu, in interest of maintaining cohesion with the objection, Theodore Booth is hereby appointed as Special Master for the Casa Del Norte subcases in Basin 37. The Special Master shall preside over the subcases and issue reports as set forth in *SRBA Administrative Order 1, Rules of Procedure* and shall have the authority to: fix the time and conditions for the filing of supplemental pleadings and amendments to pleadings; schedule and hear dispositive and nondispositive motions of any party; schedule and conduct all pretrial matters, including pretrial, status and scheduling conferences; issue pretrial orders; schedule and limit the scope of discovery; order the discovery of facts known and opinions held by experts; issue protective orders; issue orders compelling discovery; sanction failure to comply with pretrial, trial-related or post-trial orders; summon witnesses and issue subpoenas; take such evidence as may be introduced or deemed necessary by him; rule on the admissibility of evidence; call witnesses on behalf of the court; and appoint expert witnesses for the court. The Special Master shall set proceedings in conformity with *SRBA Administrative*

Order 1, Rules of Procedure, and exercise the power to regulate all proceedings in every hearing and to do all acts and take all measures necessary or proper for the efficient performance of his duties under this *Order*.

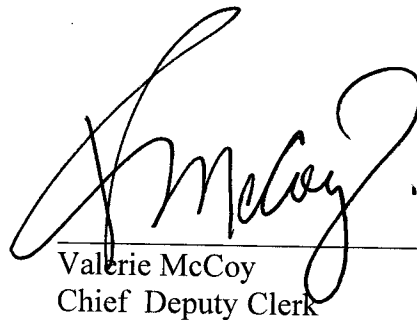
