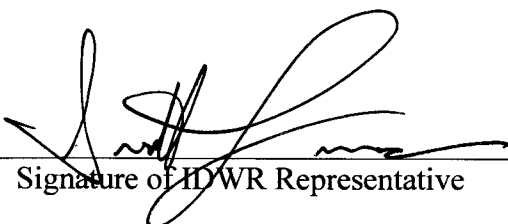
A Motion for Determination of Deferred De Minimis Domestic or Stock Water Use

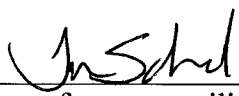

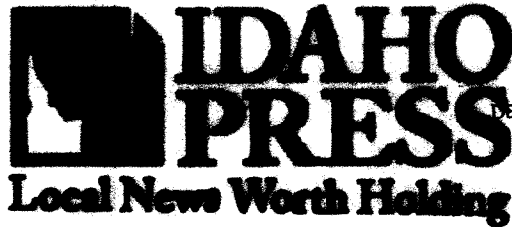

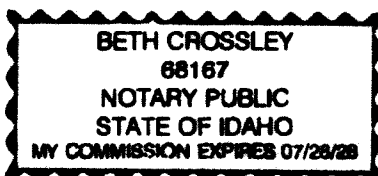
